

1.0 Policy Statement

LI Europe is committed to Safeguarding Adults in line with national legislation and relevant national and local guidelines. LI Europe's Designated Safeguarding Officer is Jeremy Praud, Company Director.

LI Europe will promote the safeguarding of adults by ensuring that our activities are delivered in a way which keeps all adults safe. LI Europe delivers training to people who work in the manufacturing environment and therefore will train individuals who are aged 18 or over. LI Europe does not employee individuals under the age of 18 and does not carry out any regulated activities.

LI Europe is committed to creating a culture of zero-tolerance of harm to adults which necessitates the recognition of adults who may be at risk, the circumstances which may increase risk and knowing how adult abuse, exploitation, or neglect manifests itself. LI Europe will report or refer all safeguarding concerns where necessary.

All staff are trained in Safeguarding Level 2, digital safeguarding, and the Prevent Duty. The designated safeguarding officer and deputy are trained in Safeguarding Level 3, digital safeguarding, Prevent Duty and Safer Recruitment. Each member of staff will complete refresher training every 2 years but will keep themselves abreast of current legislation and evidence completion of training in the Company's skills matrix and Single Central Record document.

2.0 Purpose

The purpose of this policy is to demonstrate the commitment of LI Europe to safeguarding adults and to ensure that everyone involved in LI Europe is aware of:

- The legislation, policy, and procedures for safeguarding adults.
- Their role and responsibility for safeguarding adults.
- What to do or who to speak to if they have a concern relating to the welfare or well-being of an adult within the
 organisation.

3.0 Scope

This Safeguarding Adults Policy and associated procedures apply to all individuals involved in LI Europe, including parttime staff, assessors, volunteers and support staff and to all concerns about the safety of adults whilst taking part in our organisation and in the wider community.

We expect our partner organisations, including for example, affiliated organisations and suppliers, to adopt and demonstrate their commitment to the principles and practice as set out in this Safeguarding Adults Policy and associated procedures.

4.0 Definitions

Adults at Risk of Harm

England (Care Act 2014):

An adult at risk is an individual aged 18 years and over who:

- (a) has needs for care and support (whether or not the local authority is meeting any of those needs).
- (b) is experiencing, or is at risk of, abuse or neglect.

(c) as a result of those care and support needs is unable to protect themselves from either the risk of, or the experience of, abuse or neglect.

Harm, Abuse and Neglect

Harm, abuse and neglect can take different forms, including:

Physical - for example, hitting another person or deliberately injuring yourself.

Sexual - for example, using force or threats to get someone to take part in sexual activity, or 'grooming'.

Psychological – for example, making threats, humiliating someone or bullying a person online.

Neglect - for example, not taking care of yourself or someone you have responsibility for.

Financial – for example, stealing money or borrowing it with no intention of paying it back.



Radicalisation - the process by which a person comes to support terrorism and extremist ideologies associated with terrorist groups.

5.0 Indicators of harm, abuse or neglect

LI Europe employees will receive appropriate training to be able to recognise the indicators of harm, abuse or neglect and to respond effectively where an individual makes a disclosure to them. Some potential indicators of harm, abuse or neglect are listed below. The list is not exhaustive, and it is possible for indicators to exist in isolation or in combination with others:

Agitated or anxious behaviour Excessive nervousness Increased absence A reluctance to go home Unexplained bruises or injuries, injuries that require medical attention that has not been provided or signs of discomfort or pain Inadequate clothing Hunger Poor personal hygiene A change in behaviour Inappropriate sexual behaviour Self-harm Attention seeking

6.0 Online Safety

LI Europe recognises that protecting learners online is a duty of care and should be treated in the same way as physical safeguarding.

All LI Europe employees are trained in digital safeguarding and follow best practice by doing all they reasonably can to keep learners free from harm.

7.0 Commitments

To implement this policy, LI Europe will ensure that:

Everyone involved with LI Europe is aware of the Safeguarding Adults Procedure and knows what to do and who to contact if they have a concern relating to the welfare or well-being of an adult.

Any concern that an adult is not safe is taken seriously, responded to promptly, and followed up in line with LI Europe's Safeguarding Adults Policy and Procedure.

The well-being of those at risk of harm will be put first and the adult actively supported to communicate their views and the outcomes they want to achieve. Those views and wishes will be respected and supported unless there are overriding reasons not to.

Any actions taken will respect the rights and dignity of all those involved and be proportionate to the risk of harm.

Confidential, detailed, and accurate records of all safeguarding concerns are maintained and securely stored in line with our Data Protection Policy and Procedure.

LI Europe acts in accordance with best practice advice, for example: Mental Health Act 2005 Human Rights Act 1998 Safeguarding Adults National Framework of Standards 2005 Modern Slavery Act 2015

All LI Europe staff understand their role and responsibility for safeguarding adults and have completed and are up to date with safeguarding adults training and learning opportunities appropriate for their role.

LI Europe uses Safer Recruitment practices and continually assesses the suitability of staff to prevent the employment/deployment of unsuitable individuals in this organisation.

LI Europe shares information about anyone found to be a risk with the appropriate bodies. For example: Disclosure and Barring Service, Police and Local Authority/Social Services.

This policy, related policies and the Safeguarding Adults Procedure are reviewed on a yearly basis and whenever there are changes in relevant legislation and/or government guidance, or as a result of any other significant change or event.

8.0 Procedure

When a concern is identified or an individual makes a safeguarding disclosure, the 5 Rs should be considered and followed:

Recognise

The ability to recognise behaviour that may indicate abuse. All LI Europe employees will receive training to recognise signs of potential abuse.

Respond

The ability to respond appropriately to concerns and gather more information while remaining calm and demonstrating interest. The person making the disclosure should be reassured that they have done the correct thing in making the disclosure and that it will be dealt with in a sensitive and appropriate manner.

Report

All safeguarding and Prevent concerns should be reported at the first opportunity to the Designated Safeguarding Officer or the Deputy Designated Safeguarding Officer.

Record

All Designated Safeguarding Officers and Deputy Designated Safeguarding Officers will be trained to ensure that disclosures, incidents or concerns and details of the subsequent investigation are accurately recorded, updated and monitored. They will also ensure that any information is securely stored, remains confidential and is accessible only to those who require access to provide support, in accordance with the Data Protection Policy. (LIEURAPP22003(A) Body Map can be used to record injuries).

Refer

Upon completion of an investigation or assessment, the Designated Safeguarding Officer or Deputy Safeguarding Officer will make a decision on what action to take and whether the concern should be referred to an external organisation. (LIEURAPP(B) can be used to refer).
